### 1921 SESSION LAW Senate File No. 44 — Chapter 148.

**SECTION 9.—License To Be Distinguishing Number — Duties of  
Department—**\*\*\*\*\*  
\*\*\*\*\* **In the event of the loss of a license card by any person  
duly licensed under the provisions of this act, said person may obtain a  
duplicate thereof upon filing in the office of the County Treasurer an  
affidavit showing the fact of loss and upon such filing and the payment of  
twenty-five cents fee, a duplicate license shall be issued.**

**SECTION 14.—Operating Without License—Penalty—Any person  
operating a motor vehicle on the streets, alleys and public highways in  
this state without the license required by this Act and in all particulars  
as by this Act provided, shall be deemed guilty of a misdemeanor, and,  
upon conviction, shall be punished by a fine not exceeding One Hundred  
Dollars (\$100.00), or by imprisonment in the county jail not exceeding  
three (3) months, or by both such fine and imprisonment in the discretion  
of the Court.**
