


THE MARVEL PROP PACK



Hello, True Believers!

Those first few panels of the Basic Marvel Superheroes RPG Battle Book get a lot of flak for being hokey, but I think they're great! The first time I picked up that book, I saw those panels and thought, "They look like they're having a great time!" Everyone's leaning forward, they're gesticulating enthusiastically, they're smiling, and of course, they have some miniatures out, a map, the Judge is back behind his screen, and they're all engaged.

Ever since I first started playing role-playing games, I was hooked on the immersive aspect of play. I wanted to climb into my character like a diving suit and plumb the depths of whatever worlds we were playing in. I've also always been a very visually oriented person. Being *told* something is good, but being able to *touch* it and examine it for myself has always, for me, been better. It is with this in mind that I decided to focus some of my energy on TSR's old Marvel Superheroes RPG; one of my all time, favorite games. Within are a collection of props for you to use in your own games.

Some of them, you might recognize, were originally created, and released in a number of different comic books during the 80's (Damage Control, the original Avengers' Identicons, The Vault ID card, etc.) by Marvel Comics. Others I discovered on-line (Nelson & Murdock, Nightwing Restorations, Daily Bugle Press badge & front page layout, etc.) and recreated, and yet others I made from whole cloth myself (Shield identicons, the Power Plant flier, Shaw Industries tags, etc.). Either way, I think they all add quite a bit to the Marvel gaming experience so I wanted to create, recreate, and collect them all here for the Marvel rpg community to enjoy as a whole.

The Prop Pack is broken down into two sections. The first are the ready made props. Print them up, cut them out and you're good to go!

A Word on the Props: Most everything in the Marvel Prop Pack is pretty self-explanatory. These props were designed to reflect the late 80's to mid 90's Marvel 616 Universe & time period. . .mostly. In some cases, there was no visual reference for the 616 world, so I dipped into the Marvel Cinematic Universe, provided I didn't

think it clashed too hard with the overall aesthetic I'd already established.

I also reached out to the Marvel rpg community for suggestions on the sort of props that you might find useful, and did my best to incorporate many of them into this collection.

A Word on the Templates: The second section are the collected templates that can be customized by dropping in a little text to suit your own game. I provided these to encourage Judges out there to give it a go and see how your players respond. If they like it, great! If not, no harm done.

I hope you have as much fun using these as I did making them!

Worthington Industries reveals latest breakthrough

A press conference was held early this morning at the New York Headquarters of Worthington Industries where Mark Brooks, head of the Aviation technology division, announced their latest endeavor into the field of avionics; The Daedalus ramjet, which has just successfully completed it's alpha stage trials. This propulsion system boasts a greater intake and compression rate and may threaten the positions of leading competitors in the field for market share. Worthington Industries stocks have already taken a healthy leap upward as of this morning as news of their success spreads. Mr. Brooks stated, "The Daedalus Ramjet represents a leap forward in the evolution of avionics engineering and will have a far-reaching impact on how we think about future problem solving in the field". This is smoke and mirrors." Not everyone shares that view, however. Many of those gathered at the press conference were quite impressed by the preliminary reports posted by Mr. Brooks. John Hobbs, an aeronautics engineer and private pilot said, "I'm excited by the news! Their data looks solid. I think this is the real deal. Not corporate hype." Also present was Daniel Rand, CEO of the Rand Corporation. "Worthington Industries does good work and they know avionics. If anyone could pull it off, they could."

Dissappearances on the waterfront

The west end waterfront may not often be highlighted in news stories, but this time, it is. Known for it's many warehouses and storage facilities, the waterfront is a hub of activity during the day, but at night, after working hours, it's much quieter, though that doesn't appear to be a good thing. A number of displaced individuals who have made their home on the streets of the waterfront, have been reported as missing. People come and go normally, but lately, the numbers just don't add up. John Schultz, a resident of the waterfront area had this to say. "It's not safe out there. People are being taken during the night. No one notices because no one cares about us, but it's happening. 'Watchdogs' attack mutant rights rally



Last night, a peaceful demonstration in Central Park, in support of mutant civil rights, was the target of violence when the pro-human group, 'The Watchdogs', appeared with highly advanced weaponry and began firing into the crowd while

shouting anti-mutant slogans. Terrified activists and onlookers ran for their lives as The Watchdogs advanced on the crowd. A number of activists were wounded and sadly, there were two fatalities. Police were on the scene, but

were unable to apprehend any of the Watchdogs before they broke off their attack and fled the scene. Medical services arrived quickly and the injured were taken to Saint Vincent's Hospital in haste. "It just happened so fast! They [Watchdogs] just showed up from out of nowhere and started shooting at us!", said Jeremy Blake, a student at E.S.U. Officers were busy trying to manage the screaming crowd when things turned violent, and were unable to prevent the attack. Charlotte Jones, of the NYPD gave this statement, "The wounded are now being cared for and we're grateful for the swift response from medical services. Make no mistake. This attack is inexcusable and the perpetrators will be tracked down and punished to the fullest extent of the law. There is no room in this great city for bigotry and violence." Meanwhile, some onlookers had a different view of things. Brad Chuclic witnessed the attack and commented, "Well, what are you going to do? I mean, these...people have all sorts of strange powers. . ." Cont. p.5
