Dark Side Taint

Into the Storm Clouds

The hero named above is tainted by the dark side of the Force. He or she succumbed to the will of the dark side in escaping Conkesta, and is a mere step away from going over to the dark side completely. The effects of this taint are as follow:

- The hero is stripped of all Force points.
- The hero cannot earn Force points in any way.
- The hero is treated as though he or she has a number of dark side points equal to one less than the number that would result in automatic dark side status.
- These dark side points cannot be bought off in any way the hero (or the player) knows.
- The hero will not be approached by any envoy of the Jedi Academy for adventuring purposes.
- The hero is treated as though he or she has the Infamy feat.
- The hero makes all Jedi and light side Force users extremely uncomfortable based solely on proximity.
- If the hero ever earns a dark side point, for any reason, he or she goes over to the dark side and ceases to be a player character.

If the hero is able to complete fifteen Living Force events (scenarios; interactives do not count) without earning a dark side point, the player may petition the Living Force campaign directors for an in-character resolution to the dark side taint. Keep a record on this certificate of events played, including judge names and RPGA numbers, to verify the absence of dark side points.
