The Katar Heavy Transport's interchangeable cargo modules are its stock in trade: it can shift 200 tons of cargo, 128 ground troops, or 64 power armor troops with just a few minutes of time on the landing pad to refit. Other combinations of soldiers and material are frequently found in deployment, as both passenger and barracks modules are in heavy rotation among Katar forces.

As with many other Katar vessels, when these ships reach two or three decades of age, they are often sold off to private merchants or civilian concerns as cargo haulers. What they lack in looks, they more than make up for in variety.
